## Massachusetts Attorney General – 940 CMR 31.00

The Massachusetts Attorney General has issued regulations, found at 940 Code of Massachusetts Regulations (CMR) 31.00, that require the following disclosures to be made at least 72 hours before you may enter into an enrollment agreement with The National Aviation Academy – New England. These disclosures can also be found at <a href="https://www.naa.edu">www.naa.edu</a>. The regulations define how the rates in these disclosures must be calculated.

Cost of Program The tuition and fees charged for completing a program. Application Fee: \$50.00 Registration Fee: \$100.00 Tuition: \$38,500.00	\$38,650.00
Graduation Rate  Definition: The number of students who received certificates, diplomas, or degrees in the program during the latest two calendar years (2018 & 2019), divided by the number of students who enrolled in the program during the latest two calendar years (2018 & 2019). The graduation rate shall be determined within 180 days from the end of each calendar year.	67%
Graduation Time Definition: The median completion time in which students graduate.	14 months

## Your Loan Debt

You must repay money that you borrow as student loans to pay for this program, including interest. **Total Placement Rate:**Definition: The product of the graduate placement rate and the graduation rate. The total placement rate shall be determined within 180 days from the end of each calendar year.
