



DISCLOSURE HEERF III- ARP (a)(4) STUDENT DISTRIBUTIONS REPORT

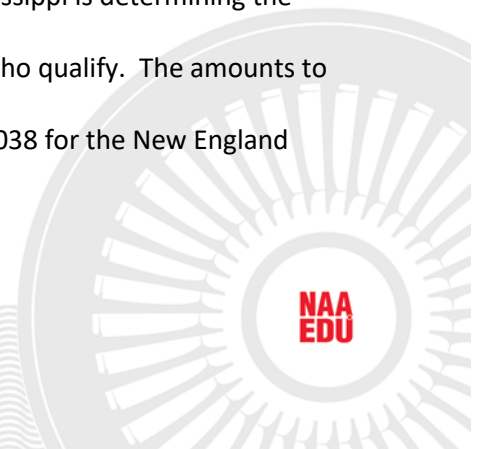

The Certification and Agreements for the ARP (a)(4) funds HEERF III, provide that each institution applying for HEERF funds must promptly and timely provide a detailed accounting of the use and expenditure of the funds in such manner and with such frequency as the Secretary may require. Each HEERF participating institution must post the information listed below on the institution's primary website, as an initial report under the ARP (a)(4) programs. This report is associated with the approved information collection under OMB control number 1801-0005.

(1) For Third Quarter 2021, the institution has zero distributions to students to report. National Aviation Academy of Mississippi Inc. has signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) HEERF I & II programs to provide Emergency Financial Aid Grants to Students. For ARP (a) (4) HEERF III National Aviation Academy of Mississippi, Inc. has not yet disbursed funds

(2) For Q3 2021 funds were received and National Aviation Academy of Mississippi is determining the method for appropriate distribution of 100% of all of the grant to students who qualify. The amounts to be disbursed include \$553,733 for the Florida campus (03035900) and \$209,038 for the New England Campus (00613600) respectively.





(4) The total number of students at the institution that are eligible to receive Emergency

Financial Aid Grants to Students under ARP (a)(4) programs HEERF III has yet to be determined. National Aviation Academy of Mississippi, Inc. acknowledges that the funds must be distributed 100% to students determined eligible for emergency aid within the prescribed timeframe.

The school has yet to determine the number of eligible students for HEERF III distributions.

(5) The total number of students who will receive an Emergency Financial Aid Grant to students under the ARP (a)(4) programs HEERF III is yet to be determined.

(6) The method(s) to be used by the institution to determine which students receive Emergency Financial Aid Grants for HEERF III is under consideration.

It must be posted as a PDF. No handwritten or scanned PDFs are allowed. Please refrain from adding additional material to the uploaded form. The 8-digit OPEID can be found at the [DAPIP website](#) or the [NCES website](#). In the event a DUNS number applies to multiple OPEIDs, use the OPEID for the campus with the highest enrollment. The quarter pertains to the calendar year, following the same cadence the reporting periods follows. The date of release should be reported as the deadline for form submission, 10 days after the end of each reporting period. A new separate form must be posted covering each quarterly reporting period (September 30, December 31, March 31, June 30), concluding after either (1) posting the quarterly report ending September 30, 2023 or (2) when an institution has expended and liquidated all (a)(1) Institutional Portion, (a)(2), and (a)(3) funds and checks the “final report” box. IHEs must post this quarterly report form no later than 10 days after the end of each calendar quarter (October 10, January 10, April 10, July 10). Each quarterly report must be separately maintained in a PDF document linked directly from the IHE’s HEERF reporting webpage.
